**Sub: Special Discount Scheme on outstanding mobile bills (CDMA-WLL & Wimax) payable upto 29-02-2012- reg.**

It has been decided by the Competent Authority to allow Special Discount of one percent (1%) on the Gross Amount (excluding Service Tax and Educational Cess amount) to all the CDMA-WLL & Wimax customers who pay their outstanding arrear bills payable upto 29-02-2012 on or before 31-03-2012. The salient features of this special discount scheme are furnished below:

1. The scheme shall be applicable to all the customers against working or closed CDMA-WLL and Wimax connections.
2. The Special Discount admissible under the scheme in respect of customers of working connections shall be credited to the customer's account and adjusted in the subsequent bill.
3. In respect of customers of closed connections, the Special Discount of one percent (1%) shall be in addition to the discount being offered to such customers through other discount schemes, if any.
4. Customers making payment through ECS, BSNL payment portal or through On Line payment mode shall also be eligible for additional Special Discount of one percent (1%) under this scheme in addition to the normal discount allowed to them for making payment through these payment modes.
5. All the BSNL bill collection centres/payment counters may remain open on 24<sup>th</sup>, 25<sup>th</sup> and 31<sup>st</sup> March, 2012 from 08:00 Hrs to 20:00 Hrs for the convenience of the customers desirous of making payment on these days.
6. The scheme shall be effective from 20/03/2012 to 31/03/2012.
7. This Special Discount Scheme will not be applicable to PCOs and PTs.

The above instructions may be given wide publicity by SSAs/Circles so that the benefit of the scheme is availed by the maximum number of customers.

A compliance report on the implementation of this scheme with amount realized may be furnished to this office by 15-04-2012.
