## **Circular T&C-CM No. 43/13-14**

## Sub: Waiver of C-Top-up SIM replacement charges -reg.

Kindly refer to this office order of even No. 07.01.2010 and orders/clarifications issued from time to time vide which the charges relating to replacement of defective C-Top-up SIM have been issued. Now based on feedbacks received from field units it has been decided by the competent authority to waive off the C-Top up SIM replacement charges with the following terms and conditions:-

- i) Replacement charges for C-Top up SIM is waived off in genuine cases only i.e. if the defect in the C-Top up SIM is due to technical reasons beyond the control of C-Top-up retailer/franchisee etc.
- ii) In case, there is a loss of SIM or the defect in SIM is due to negligence of customer, replacement charges of Rs.20 may be taken from the C-Top-up retailer/ franchisee etc. for replacement of C-Top up SIM.
- 2. The above tariff is applicable to both prepaid and postpaid C-Top-up plans.
- 3. The above revision will be implemented with effect from **01.10.2013**.
- 4. This may be brought to the notice of all concerned for taking necessary action in this regard. Circles may also send SMS conveying the above offer to the franchisees/retailers.
- 5. This circular is issued based on approval in P&P-CM cell file No. 2-2/2012-P&P-CM (Pt.III).
