Subject: Withdrawal of Annual Plan (1) Plan-600(Rural), (2) Plan-1200(Urban) & (3) Plan 2160 (Biennial) -reg.

Kindly refer to this office letter of No.3-18/2005-R&C dated 23.04.2008 (Circular No.6) through which the annual/biennial fixed charges plans for Landline and WLL Services viz. Plan-600 & Plan 1000 in Rural Area and Plan 1200, Plan 1800 & Plan 2160 (Biennial) in Urban Area were introduced and letter No. 3-21/2008-R&C dated 24.02.2009 (Circular No. 83) containing instructions regarding Exit option prior to the hire period of one/two years. Reference is also invited to this office letter of No.3-11/2009-R&C [CFA] dated 31.05.2010 (Circular No.04/10-11) through which the annual Plan-1000 (Rural) and Plan-1800 (Urban) were withdrawn.

2. Matter has further been examined in this office and it has been decided by the Competent Authority that Annual Plan-600 (Rural), Annual Plan-1200 (Urban) & Biennial Plan 2160 (Urban) shall not be offered to the prospective customers henceforth for new subscription. Accordingly, the approval of the Competent Authority is hereby conveyed for withdrawal of Annual Plan-600 (Rural), Annual Plan-1200 (Urban) & Biennial Plan 2160 (Urban) with immediate effect with the following conditions:

- I. Customers who are at present registered under Annual Plan-600 (Rural), Plan-1200 (Urban) & Biennial Plan 2160 (Urban) may be asked to subscribe to other alternative plans best suited to them on expiry of committed period.
 - II. In case any subscriber opts for migration to alternative plan before completion of committed period, the instructions contained in letter no 3-21/2008-R&C dated 24.02.2009 (Circular No. 83) shall be followed.
3. These instruction shall have immediate effect.
 4. This may be brought to the notice of all concerned for taking necessary action.
 5. The Circular is issued based on the approval of Competent Authority in NWO-CFA file No. 25-34/2011/ NWO-CFA / IN. For any clarification/correspondence in respect of aforesaid plans, matter may be taken up with NWO-CFA branch of BSNL CO (Tel. No. 011-23714148 Fax 011-23734366)
