Kindly refer to this office letter mentioned above wherein it was intimated to open UAN for full charge/ split charge for access to IN numbers of BSNL. In this letter standard range of subscribers of UAN (Local /Split) and UAN (Long distance/Full Charge) was given as 5000-9999 & 0000-4999 respectively. In respect of query raised vide reference letter at (i) above, it is clarified that the above range prescribed by BSNL was generic and for administrative convenience but there are exceptions as given in list of Annexure-I, to this rule as these numbers were opened prior to this rule coming into force & even prior to interconnect agreement for UAN IN Service with other Private Operators.

It is also intimated that most of these numbers are being used by UAN Customers of BSNL for the last several years. Therefore, it is not possible at this point of time to change these numbers of UAN Customers of BSNL to comply with generic UAN range. Charging of these UAN numbers is being done on actual basis in BSNL ir-respective of the range of these numbers.

The allotment of UAN numbers will be according to standard range as prescribed by BSNL CO vide letter at ref (ii) above except the UAN codes mentioned in Annexure-I to avoid confusion in future.
