Reference has been received from Kerala circle for reducing LD charges of Rs.10 Lakhs as said in Clause No. 8.2.4 of Schedule-I of the EPABX franchisee draft agreement in view of reduction in the PBG amount from Rs.25 Lakhs to Rs. One Lakh for empanelment of circle level EPABX franchisees conveyed vide this office letter dated 13.10.2009.

The case has been examined in BSNL corporate office and following modifications in the draft agreement of EPABX franchisee has been approved by the competent authority for all circles in respect of empanelment of circle level EPABX vendors under free EPABX scheme:

Sub: Empanelment of vendors by circles for providing last mile services - clarifications regarding.

BSNL Corporate Office had floated an EOI for empanelment of EPABX vendors for providing last mile services on national level. Circles were subsequently asked to empanel vendors at circle level on same terms and conditions to increase the availability of more EPABX vendors.

A clarification was received from Haryana Telecom Circle for relaxation of financial terms and conditions w.r.t. PBG and turnover of the prospective EPABX manufacturers/ distributors. As vendors to be empanelled at circle level cannot have the same eligibility criterion as stipulated for national level vendors, hence a proposal for relaxation was put up for consideration. The proposal has been considered in BSNL Corporate Office and the competent authority has approved the following:

- (i) Performance Bank Guarantee (PBG): PBG fixed at Rs. 25,00,000/- for providing services at national level is revised to as Rs. 1,00,000/- for circle level EPABX vendors. The empanelled vendors shall collect the bill payments from subscribers on behalf of BSNL in the form of banking instrument drawn in favour of BSNL and no cash collection from subscribers should be allowed.
- (ii) Annual Turnover limit: The annual turnover of prospective EPABX manufacturers/distributors has been revised to Rs. 50,00,000/- per year during each of the three most recent financial years for circle level from existing Rs. 2 Crore for national level EPABX partners.

The other terms and conditions of EOI & Agreement shall remain unchanged.
