The FMC (Fixed Monthly Charges) in respect of General Category landline/WLL (Non-MSC) customers of rural area has been reviewed and <u>Competent Authority has decided to enhance the FMC from Rs. 50/- per month to Rs 60/- per month</u>, where <u>exchange capacity is less than 1000 lines</u>.
