## Subject: Rationalization of existing rates for ISD calls made from Landline network in Rs/ Minutes-reg.

Kind reference is invited to this office letter No. 3-1/2010-R&C(CFA) dated 31.07.2012 (Circular No. 14/12-13) vide which the ISD tariff (MCU based) was rationalized for landline services. Reference is also invited to NWO-CFA cell letter No. 25-10/2011/NWO-CFA/IN dated 30-08-2012, vide which tariff implementation issues raised by ITPC Hyderabad were clarified. Now it has been brought to the notice of this office that <u>ISD Code 004470 for UK</u> is the premium code and charges payable to ILD carrier is high. <u>Hence it has been decided by the Competent Authority to revise the ISD tariff for ISD code **004470 for UK as Rs.25/Min**.</u>

2) It is further clarified that TRAI in its Explanatory Memorandum to Telecom Tariff (Fifty First Amendment) Order 2012 (No. 2 of 2012) dated 20-04-2012, has decided to exclude ILD call rates from the purview of tariff protection envisaged vide 43<sup>rd</sup> amendment. As such any upward or downward revision in ILD tariff shall be applicable to all subscribers uniformly irrespective of the date on which the subscriber was enrolled into a tariff plan.

- 3) The above revision is applicable to all landline /WLL NON-MSC customers and will be effective from 25-09-2012.
- 4) This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.
