Subject:-Re-launch of Discount scheme for defaulters under Basic/ WLL and CMTS (Postpaid) Services for realization of outstanding dues against closed Connections, from 10-2-2015 to 31.3.2016 regarding.

Proposals were received in this office from several Telecom Circles requesting for re-launch of discount scheme. These proposals were examined and placed before the Management Committee of the BSNL Board for consideration. The Management Committee in its 230th meeting held on 04-02-2015 has approved the proposal for re-launch of discount scheme **up to 31.3.2016**. The scheme is relaunched from **10.02.2015 to 31.3. 2016** with the discount structure indicated hereunder:

SI.No.	Age of outstanding dues as on 31.12.2014	Discount admissible
1	Up to 1 (one) year old	Nil
2	> 1 year old to 2 years old	10%
3	> 2 years old to 3 years old	15%
4	>3 years old to 10 years old	25%
5	>10 years old	50%

The other terms and conditions of the scheme as prescribed in this office letter of even No. dated 22.10.2008 read with amendment dated 4.12.08 remain unchanged except that the scheme shall be applicable now for the phones disconnected up to 31-12-2014.

All the Heads of Circles /Metro Telephone Districts are requested to give wide publicity to the scheme in phase manner. (1) it is published that the scheme is re-launched only up to 31-3-2015. So, that maximum outstanding amount may be recovered during this financial year 2014-15. (2) Secondly it may be published for the year 2015-16 after year ending March,2015 besides instructing the staff suitably to put in concerted efforts for the success of the scheme by way of effecting maximum recovery of outstanding dues from defaulters. The discount should be allowed as per prescribed rate only. The SSAs wise progress should be monitored personally by the CGMs & Circle IFAs and prompt remedial action taken in the event of slippages in performance as well as the rate of discount, wherever noticed.

Circles shall continue to send monthly SSA wise progress report as per the proforma already prescribed vide this office letter of even No. dated 22.10.2008. The progress report may also be e-mailed at mailing address kuberbsnl1@gmail.com
