Subject: Revision of ISD tariff for Landline/FLPP (Gen)/WLL, Landline PCOs/ FLPP PCOs/ WLL PCOs/VPT PCOs and VCC -reg.

Kind reference is invited to this office letter No. 3-1/2010-R&C(CFA) dated 21.01.2011 and dated 28.02.2011 [Circular No. 51/10-11 & 58-10/11 respectively] through which the ISD tariff for calls made through VCC, BSNL Fixed, FLPP(Gen) and WLL phones and Landline/WLL/FLPP/VPTs PCOs was modified for some Countries.

The Competent Authority has now decided to revise the existing ISD tariff for calls made from (1) BSNL Fixed, FLPP (General) and WLL phones (2) Landline-PCOs /WLL-PCOs /FLPP-PCOs /VPTs PCOs and (3) VCC to destinations falling in the eighty (80) Countries mentioned in Annexure.

- 2) ISD rates of all other Countries will remain unchanged. Charge Band Information for new pulses will be issued separately by NWO-CFA cell.
- 3) The pulses/rates of Land Line and WLL will also be applicable for "BSNL One India"/Other Alternate package and Trunk calls.
- 4) The revised tariff will be applicable from 1<sup>st</sup> of June, 2012.
- 5) The usual TRAI guidelines regarding tariff implementation shall be followed scrupulously by all units.
- 6) This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.
