Subject: Proposal for increasing the FMC of "Sulabh plan" from existing Rs. 99/- P.M. to Rs. 120/- P.M.

CGM UP (W) through his office letter No. UPW/CFA/Mktg/circular/2010-11/68 dated 17-01-2013 addressed to GM(NWO-CFA) CO, BSNL, ND has proposed to increase the rate of Fixed Monthly Charges of "Sulabh Plan" from Rs. 99/-P.M. to Rs. 120/- P.M. in Noida and Ghaziabad SSA of UP (W) Telecom Circle, as initially introduced in Maharashtra, Karnataka, & Punjab Circle vide CO BSNL, ND Circular No. 3-4/2009-R&C [CFA] dated 12-11-2012.

The matter has been considered on the recommendation of the Tariff Committee-CFA and the Competent Authority has approved to increase the rate of Fixed Monthly Charges of "Sulabh Plan" from Rs. 99/-P.M. to Rs. 120/- P.M. for Telephone Exchanges as per NWO-CFA Branch, CO BSNL letter No. 25-62/2011/NWO-CFA. IN dated 2.01.2013 on the subject) as given below:-

2. The revised tariff will be applicable from 1st March 2013.
3. All regulatory requirements may kindly be complied with while implementing the above tariff.
4. This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.
5. This circular is issued based on the approval of Competent Authority in PDP-CFA file No. 8- 5/PDP-CFA/ 2012-13. For any clarification /correspondence in respect of aforesaid scheme, matter may be taken up with PDP-CFA unit of BSNL CO, New Delhi.
