Subject:- Delegation of financial powers under de-centralized items.

Approval of the Board of Directors of the Company vide Board CR No. 02 of 2013-14 is hereby conveyed to delegate full powers to the Heads of Circles for the procurement of the de-centralized items without the restriction of Rs.3 crores (Rupees Three crores) as given under item no. 17.1 of the existing delegation of financial powers, subject to budget allotment, norms and the procedure laid down for procurement of de-centralized items.

The revised delegated powers will be as under:

Item no.	Previous powers of Heads of circles as per letter no. 6-15/2000-EB dated 28.2.2002	Revised powers as per the approval of the competent authority
4.2 of the delegation of financial powers	“Full powers for purchase against rate/ prices finalized by tenders by the Head of circle subject to the quantitative limits of the materials and budget allocation for the items prescribed by the BSNL Board and as per the standards.”	“Full powers to the Head of circle for de-centralized items without restriction of Rs.3 crores as given under item no.17.1 of the delegation of financial powers subject to budget allotment, norms and the procedures laid down for procurement of the de-centralized items.”

Conditions:-

1. The exercise of financial powers will be subject to the strict observance of rules, orders instructions and guidelines issued by DOT, DTS, DTO and BSNL in this regard from time to time and the availability of the funds and austerity measures / guidelines.
2. The powers are to be exercised with the concurrence of concerned IFA.
3. This order will remain effective till further orders.
