This has reference to the letter issued to M/s Novatium as mentioned above . Detailed of the approved scheme are furnished hereunder for the information of all field units:

- (1) This is an extension of the existing agreement signed between BSNL and M/s Novatium on 24<sup>th</sup> of December, 2008 for offering thin client based computing services to the customers. All the terms and conditions of the existing agreement shall be applicable subject to modifications / revisions as mentioned in the following clauses.
- (2) The scope of this revised agreement is upto 31 Broadband connections/ DSLAM in the rural Broadband network of BSNL for which USO subsidy is applicable.
- (3) Following shall be the costing of the PC.

### (5) **Procedure**:

- a. BSNL shall forward all requests (including customer details) to M/s Novatium for delivery of Novanet PC to the customer premises upon request from the customers.
- b. The shipment of equipment to the doorsteps of the customer shall be done by M/s HCL within 21 days of the receipt of the intimation.
- c. The installation of the equipment at the customer end shall be completed within 3 days of the arrival of the equipment at customer location.
- d. The intimation about installation of the equipment at customer location shall be forwarded by M/s HCL to BSNL by:
  - i. In writing (furnishing details of the equipment, CPU no. etc.)
  - ii. By submitting a copy of the agreement between M/s Novatium, the customer and insurer

### (6) Payments

- a. M/s Novatium will generate a consolidated invoice to BSNL for the USO component against which payment is to be made by BSNL.
- b. USOF subsidy component (of Rs. 4,500/- per unit) will be claimed by BSNL and will be paid to M/s Novatium on receipt of the same.
- c. The refundable advance (one time), monthly installment will be billed by BSNL in the Broadband Bills and will be paid to M/s Novatium on producing the claim and after realizing the same from the customers.
- d. BSNL shall deduct its revenue share due to it before making payments to M/s Novatium as in (c) above.

## (7) Commission/ administrative charges to be paid to BSNL :

Rs. 72.75/- (Rs. 50/- + 13% of Rs. 175/-) per month on the equated monthly installment paid by the customer.

## (8) Maintenance:

- a. M/s Novatium shall provide 36 months nationwide warranty from the date of installation of the equipment at the customer premises.
- b. The warranty shall be available on site
- c. Post 36 months, the warranty will continue, however any part replacement shall be done on actuals.

### (9) Replacement

M/s Novatium shall be liable to replace the customer end equipment in case of any upgrade in the equipment/ end of support for the existing version.

#### (10) Insurance

- a. In case of discontinuance of the Nova utility service by the customer during the lock-in period, BSNL will not have any responsibility for either the recovery of Nova Net PC or to pay the charges to Novatium for the balance period.
- b. In order to ensure the payment of monthly amount, the product might be insured through an insurance agency by M/s Novatium.

### (11) Collection of Net PC on surrender by customer:

The intimation of surrender of the Net PC by the customer will be forwarded by BSNL to M/s Novatium which will collect the equipment & store the same till handing over to the next customer.

#### (12) Penalty

The penalties in case of delay by M/s Novatium in delivery/ installation/ warranty support etc. shall be finalized in due course and intimated separately.

#### (13) Other terms and conditions:

- a. Each customer subscribing to this scheme shall agree to lock-in period of 36 months.
- b. M/s Novatium will be responsible for the marketing of the scheme.
- c. This agreement will come into force with immediate effect.
- d. The Agreement between M/s Novatium and BSNL is on non-exclusive basis.
- e. Representatives of M/s Novatium will contact BSNL Circle Heads within 15 days from the date of issue of this letter to workout the logistics.
