SUBJECT: Opening of ISD code '00211' for 'South Sudan' from BSNL network and prescribing ISD tariff thereof for ISD calls made from Landline PCOs / FLPP PCOs / WLL (Fixed) PCOs / VPT (Fixed) PCOs.

Kind reference is invited to this office letter No.3-1/2010-R&C [CFA] dated 24-09-2012 (Circular No.32/12-13) vide which approval for opening of ISD code '00211' for 'South Sudan' from BSNL network and ISD tariff for the calls made from landline network to said country was prescribed.

<u>Competent Authority has now approved the tariff for ISD calls made from BSNL Landline PCOs / FLPP PCOs / WLL (Fixed) PCOs / VPT (Fixed) PCOs to `South Sudan' ISD code '00211' as Re.1/- per MCU with the pulse rate of 1.3 seconds.</u>

2. The above tariff shall be effective from 20-10-2012.

- 3. All terms and conditions prescribed for ISD tariff to other countries, modified from time to time, shall be applicable in this case also.
- 4. This may be brought to the notice of all concerned and necessary steps may be taken for its proper implementation.
