Subject:- Introduction of MOU based Tariff in Universal ITC (UITC)

Kindly refer to this office letter No. 3-1/2010-R&C [CFA] dated 07.07.2010 (Circular R&C-CFA No. 15/10-11) introducing per second pulse by merging the features of ITC, Call Now & Gulf call now cards and subsequent letters of even no dated 06-08-2010, 20-10-2011, 30-03-2012 carrying approval for extension and revision of talk value consequent upon enhancement of service tax. Reference is also invited to various orders issued from NWO-CFA/IN conveying approval for further extension from time to time.

The matter has been further reviewed in this office and Competent Authority has now decided to introduce MOU based Tariff in UITC as per following:-

1. For Local & STD calls Tariff in Rs/Minute will be as below:

- MOU based ISD tariff applicable for General Landline Plan, modified from time to time, shall also be applicable for ISD calls made by using ITC/UITC cards.
- The other terms and conditions/guidelines including Card Value/ Talk value shall remain unchanged.
- The above tariff shall be applicable to all the cards to be generated after 15th July 2013.
- Existing tariff (paisa/second) shall continue for cards/e-PINs already generated/ printed and in circulation either at BSNL /distributor or customer end. **Validity of such cards i.e. cards / e-PINs already generated/ printed and in circulation either at BSNL /distributor or customer end, shall not be extended beyond expiry of life period.**
- The Circular is issued based on the approval of Competent Authority in NWO-CFA/IN file no.25-13/2011/NWO-CFA/IN.
