Subject :- Extension of Per Second Pulse Tariff Scheme for "Universal ITC" card.

Kindly refer to BSNL CO letter No. 3-1/2010-R&C [CFA] (Circular R&C -CFA No. 15/10-11) dated 07.07.2010 & 3-1/2010-R&C [CFA] (Circular R&C-CFA No 22/10-11) dated 06.08.2010 vide which a new prepaid calling card "Universal ITC" was introduced with Per Second Pulse Tariff Scheme w.e.f.10.07.2010 for a period of six month.
