**Subject: Revision of Annual payment option under WiMax Broadband services - reg.**

Kind reference is invited to this office letter no. 3-4/2009-R&C [CFA] (circular no. 72/12-13) dated 13.03.2013 conveying approval of the competent authority to rationalize the advance payment of Fixed Monthly Charges (FMC) Plans viz; Annual, Two years, Three years payment option for Landline, Broadband services.

2. Now, **it has been decided by the competent authority to revise the charges from existing 10 months FMC to 11 months FMC under annual payment option for the WiMax Broadband services across all the WiMax Broadband plans including VPNoWiMax plans.**
3. The existing WiMax Broadband customers, already under annual payment option, shall not be charged the revised tariff till the expiry of their current annual subscription.
4. **The revised tariff shall be applicable w.e.f. 01-11-2013.**
5. **The circle/ Metro District shall ensure to comply with all regulatory requirements.**
6. Impact of the above tariff may be analyzed and feedback may be submitted on monthly basis to T&C-CFA and NWP-BB (CFA) branch of Corporate Office electronically at [tccfa.hq@bsnl.co.in](mailto:tccfa.hq@bsnl.co.in), [tccfa.bsnl@gmail.com](mailto:tccfa.bsnl@gmail.com) and [broadbandbsnlco@gmail.com](mailto:broadbandbsnlco@gmail.com) respectively for further review.
