## Circular R&C-CFA No. 41/14-15

Subject: Clarification/Guidelines to be followed by Tamilnadu circle regarding buyback of working WiMax CPEs where BWA spectrum surrendered - reg.

- 1. The case has been examined by the NWP-BB cell & tariff committee of BSNL C.O. and following been decided by the competent authority:
  - a. In the Tamilnadu circle where BWA spectrum has been surrendered, BSNL may buyback working CPEs @ Rs.500 from the WiMax BB customers who have out rightly purchased the CPE/Modem from BSNL.
  - b. Tamilnadu Circle shall ensure that CPEs have been recovered in good working condition.
- 2. Sr. GM (NWP-CDMA/WiMax) shall ensure that recovered CPEs from Tamilnadu circle are properly utilized in other circles where WiMax services are working.
- 3. All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
- 4. These instructions shall be effective with immediate effect in Tamilnadu circle where BWA spectrum has been surrendered.
- 5. This circular is issued based on the approval of Competent Authority in Broadband cell file No.64-277/2013/WiMax/Tariff/Pt.3.
